

Minutes of the Meeting of the Open Meeting of the Board of Regents of Northwest Missouri State University Friday, January 30, 2009

The Board of Regents of Northwest Missouri State University met on Friday, January 30, 2009, in the Board Room of the J. W. Jones Student Union at 1:00 p.m. after notice was duly given to each member of the Board.

The following members of the Board were present: Mr. Bill Loch, president of the Board; Mrs. Rita Hanks; Mr. Doug Sutton; Ms. Lydia Hurst; Ms. Rachelle Brown; Mr. Gary Panethiere and Mr. Bradley Gardner. Mr. Don Schneider, vice president of the Board, participated by telephone. Dr. Dean L. Hubbard, president of the University, was also present. Dr. Douglas Wyckoff was absent.

OPEN SESSION

Roll call was taken and, a quorum being present, Regent Loch called the meeting to order and the following business was transacted.

Resolution # 8382: Regent Panethiere made a motion, seconded by Regent Hanks, to adopt the following resolution honoring Coach Steve Tappmeyer, Head Men's Basketball Coach. Motion carried unanimously. Board President Loch read the Resolution as follows:

WHEREAS, Coach Steve Tappmeyer, now in his 21st season of leading the Bearcat men's basketball team, is the winningest coach in program history, and

WHEREAS, Coach Tappmeyer recently achieved a significant milestone in earning 400 career victories as a head coach, and WHEREAS, Coach Tappmeyer's teams have won 15 or more games in each of the last 11 seasons, thus setting a program record, and WHEREAS, Coach Tappmeyer has been selected the Mid-America Intercollegiate Athletics Association's Coach of the Year four times and has led teams to four MIAA Tournament titles, and

WHEREAS, under Coach Tappmeyer's proven leadership, Bearcat players have consistently achieved excellence both on and off the court, with three earning conference Most Valuable Player honors over the past 10 years and four being declared All-Americans, and WHEREAS, in both the 2001-02 and 2003-04 seasons Northwest squads won 29 games and became the first two Bearcat teams to reach the NCAA Division II Tournament Elite Eight, and

WHEREAS, Coach Tappmeyer has received numerous honors and awards testifying to his coaching excellence and commitment to the development of young people as athletes, scholars and citizens, including the Kodak Coach of the Year Award and regional Coach of the Year honors, and

WHEREAS, basketball teams under Tappmeyer's leadership have provided excitement and countless thrills to Bearcat fans everywhere, and especially in Bearcat Arena, where the team has gone 135-20 over 11 complete seasons,

THEREFORE BE IT KNOWN that the Board of Regents of Northwest Missouri State University on this THIRTIETH DAY OF January, two thousand and nine, adopts this resolution to honor Head Men's Basketball Coach Steve Tappmeyer and to express its deepest congratulations for his achievement of 400 career wins.

Resolution #8384: Regent Sutton made a motion, seconded by Regent Panethiere, to approve the curriculum changes:

- 1) The Bachelor of Science in Nursing RN TO BSN Completion Program will consist of:
 - 42 hours of general education;
 - 6 hours of institutional requirements
 - 50 hours of required courses in the major
 - 26 hours of electives

The program requires the following new courses: Theories and Models of Nursing, Healthcare Delivery Systems, Pathophysiology, Intermediate Pharmacology, Leadership and Management in Nursing, Health Assessment, Community Nursing, Family and Child Nursing, Gerontological Nursing, Informatics in Nursing, and Research Methods in Nursing.

- 2) Bachelor of Science in English Education: Change in the Major:
 - Requires a new grammars course, School house Grammars and Pedagogy
 - Allows Multiethnic Literature or Modern and Contemporary World Literature to be used as a substitution for a survey course
 - Requires all students to take Introduction to Teaching Writing

Motion carried unanimously.

Resolution #8385: Regent Panethiere made a motion, seconded by Regent Hanks, to approve the retention of BKD as independent auditors for FY 2008-2009. Motion carried unanimously.

<u>Resolution #8386:</u> Board President Loch read a letter from Regent Wyckoff (appended) concerning the transfer of the University Farm from the Northwest Foundation to the University. Regent Wyckoff was unable to attend the meeting.

Regent Panethiere made a motion, seconded by Regent Hurst, to accept the transfer of the land from the Northwest Foundation to the University. A roll call vote was taken with the following results.
