

## DRAFT Minutes of the Meeting of the Open Meeting of the Board of Regents of Northwest Missouri State University

The Board of Regents of Northwest Missouri State University met on Thursday, March 26, 2009, by telephone, at 9 a.m., after notice was duly given to each member of the Board.
