

## DRAFT Minutes of the Meeting of the Open Meeting of the Board of Regents of Northwest Missouri State University Monday, April 20, 2009

The Board of Regents of Northwest Missouri State University met on Monday, April 20, 2009, by telephone, at 5:00 p.m., after notice was duly given to each member of the Board.

## **OPEN SESSION**

Roll call was taken with a quorum present.

<u>Resolution #8427</u>: Regent Wyckoff made a motion, seconded by Regent Brown, to appoint Regent Hurst as President pro tem in the absence of Board President Bill Loch and Board Vice President Don Schneider.
