

Open Meeting Minutes of the Board of Regents of Northwest Missouri State University Wednesday, June 27, 2012, 3 p.m.

The Board of Regents of Northwest Missouri State University met on Wednesday, June 27, 2012, in the Center/East Meeting Room of the Station on the campus of Northwest Missouri State University at 3 p.m., after notice was duly given to each member of the Board.
