

Northwest Missouri State University Board of Regents Open Meeting Minutes Friday, February 1, 2013, 2 p.m.

The Northwest Missouri State University Board of Regents met at 2 p.m. Friday, February 1, 2013, in the Northwest Missouri State Student Union Board Room after notice was duly given to each Board member.

The following members of the Board were present: Board Chair Mark Hargens, Board Vice Chair Joe Bosse, Mr. Gene Dorrel, Mr. John Richmond, and Student Regent Ashton Raffety. OPEN SESSION

A quorum being present, Regent Hargens called the meeting to order at 2 p.m. and roll call was taken. Regent Hargens welcomed the two new board members: Regent Pat Harr and Regent John Richmond.

<u>Resolution #8947:</u> Regent Dorrel made a motion, seconded by Regent Bosse, to approve the curriculum proposal in agenda item 02-13-02. <u>Proposal 112-17-02.</u> Establish a new MSEd degree (MSEd Elementary Mathematics) that incorporates the coursework necessary for the Elementary Mathematics Specialist DESE certification (previously approved). At its December 2012 meeting, the Board of Regents approved courses that will lead to certification as an Elementary Mathematics Specialist. This proposal combines an additional 8 hours of appropriate coursework – 2 hours of new courses – to the certificate program that will allow students to complete the requirements for a Master's degree. MSEd Elementary Mathematics: Program Admission Requirements

- 1. A minimum overall grade point average of 2.75 on the undergraduate transcript or an undergraduate overall GPA of 2.50 to 2.74 and a 3.25 GPA on eight hours of required graduate coursework at Northwest in the major program where admission is requested.
- 2. A valid teaching certificate.
- 3. Two or more years of teaching experience.
- 4. A current teaching position in elementary school or middle school mathematics.
- 5. A letter of recommendation from a current administrator who has completed a performance-based annual evaluation on which the teacher has achieved the level of *developing* or higher.
- 6. Successful completion of the Analytical Writing Assessment.
