

## Northwest Missouri State University Board of Regents Open Meeting Minutes Thursday, March 13, 2014, 1 p.m.

The Northwest Missouri State University Board of Regents met at 1 p.m. Thursday, March 13, 2014, in the Northwest Missouri State Student Union Board Room pursuant to public notice given March 12, 2014.

The following members of the Board were present: Board Chair Mark Hargens, Board Vice Chair Joe Bosse, Mr. Gene Dorrel, Dr. Pat Harr, Mr. John Richmond and Student Regent Ashton Raffety. Also present were: University President John Jasinski and Attorney Hayley Hanson.

## **OPEN SESSION**

A quorum being present, Regent Hargens called the meeting to order at 1 p.m. and roll call was taken.

## **CONSENT ITEMS:**

<u>Resolution #9111:</u> Regent Harr made a motion, seconded by Regent Bosse, to amend the agenda to add a previous request from Missouri Governor Jay Nixon to address the board.

Resolution #9112: Regent Bosse made a motion, seconded by Regent Harr, to approve the consent item as amended. A roll call vote was taken: Regent Bosse, yes Regent Dorrel, yes Regent Harr, yes Regent Harr, yes Regent Hargens, yes Motion carried unanimously.

Resolution #9113: Regent Dorrel made a motion, seconded by Regent Bosse, to approve of the curriculum proposals summarized in agenda item 03-14-02. Resolution #9114: Regent Dorrel made a motion, seconded by Regent Harr, to approve of the Service Animal Policy summarized in agenda item 03-14-03. Resolution #9116: Regent Bosse made a motion, seconded by Regent Harr, to approve renaming the Foster Aquatic Center to the Robert & Virginia Foster Fitness Center as summarized in agenda item 03-14-05. A roll call vote was taken: Regent Bosse, yes Regent Dorrel, yes Regent Harr, yes Regent Richmond, yes Regent Hargens, yes Motion carried unanimously.

<u>Resolution #9117</u>: Regent Bosse made a motion, seconded by Regent Harr, to approve of the FY15 rate increases as presented in agenda item 03-14-06 that includes: 0% for undergraduate tuition which would increase to 1.5% if FY15 state appropriations fall below a 5% core funding increase; 1.5% for graduate tuition; designated fees; non-standard program fees; and room and board rates averaging 3.0% as summarized in agenda item 03-14-06.

A roll call vote was taken: Regent Bosse, yes Regent Dorrel, yes Regent Harr, yes Regent Richmond, yes Regent Hargens, yes Motion carried unanimously.

Resolution #9118: Regent Dorrel made a motion, seconded by Regent Bosse, to approve of a technology purchase through Hewlett Packard, not to exceed \$4,810,000 and utilizing a three-year interfund loan with annual payments between the Education and General Fund and the Plant Fund as summarized in agenda item 03-14-07. A roll call vote was taken: Regent Bosse, yes Regent Dorrel, yes Regent Harr, yes Regent Richmond, yes Regent Hargens, yes Motion carried unanimously.

Chair Mark Hargens left the meeting at 1:31 p.m. due to a conflict of interest for the legal contract discussion and vote.

Regent Gene Dorrel chaired the meeting at this time.

<u>Resolution #9119:</u> Regent Harr made a motion, seconded by Regent Bosse, to approve of retaining Husch Blackwell as legal counsel for Northwest Missouri State University as summarized in agenda item 03-14-08.
