

Northwest Missouri State University Board of Regents Open Meeting Minutes Wednesday, November 19, 2014, 5 p.m.

The Northwest Missouri State University Board of Regents met at 5 p.m., Friday, November 19, 2014, in the Northwest Missouri State Administration Building President's Seminar Room pursuant to public notice given November 18, 2014.
