

Northwest Missouri State University Board of Regents Open Meeting Minutes Friday, October 23, 2015, 10 a.m.

The Northwest Missouri State University Board of Regents met at 10 a.m. on October 23, 2015 in the Northwest Missouri State University Boardroom of the J.W. Jones Student Union pursuant to public notice given October 21, 2015.
