

# Northwest Missouri State University Board of Regents Open Meeting Minutes March 16, 2017, 1 p.m.

The Northwest Missouri State University Board of Regents met at 1 p.m. on March 16, 2017 in the Northwest Missouri State University Boardroom of the J.W. Jones Student Union, pursuant to public notice given on March 14, 2017.

#### Student Senate – Hannah Sears

- Accomplishments of the past year by Student Senate:
  - o Created a sustaining infrastructure within Student Senate.
  - Developed ongoing relationships with Northwest Leadership Team, Faculty Senate and Staff Council.
  - Aligned with the University's strategic plan.
  - o Created a Diversity, Equity and Inclusion committee.
  - o Increased membership from 30 to 70.
  - Completed a successful blood drive and food drive.
  - Northwest is ranked in the Top 25 Colleges for number of students registered to vote this past fall trimester.
  - o Assisted with International Student Day at the State Capitol.
  - o Hosted a legislative reception at the State Capitol.
  - o Input into the FY18 budget working with Vice Presidents Baker and Carrick.
  - o Will host "Seeing Purple" in April with alumnae Lisa Gruenloh as the speaker.

- Topics addressed included: Budget work; Pay It Forward; emergency management procedures successfully followed during recent tornado; excellent rating by DESE for the School of Education; MCC-Blue River campus toured campus as part of our ongoing partnership; successful Career Fair; aligned and partnering with Student Senate, Faculty Senate and Staff Council; the Association of Black Employees inaugural scholarship banquet raised \$10,000 for scholarships; Northwest, for the first time in school history, hosted the NCAA men's regional basketball tournament; Mrs. Jasinski hosted 60 students, alumni and professionals at the Gaunt House for an AdInk networking session as well as hosting the men's basketball team, their families, alumni and donors during the recent NCAA regional tournament; third quarter report about Forever Green shows 58 percent to goal (ahead of schedule) and 46 members have joined the First 50 for the Northwest Multipurpose Center; alternative spring break has 29 students traveling to New Orleans; and Northwest has a total of 38 national championships which includes most recently the Speaking Bearcats champions and the men's basketball regional tournament champions.
