The Northwest Missouri State University Board of Regents met at 8:30 a.m. on October 23, 2019 in J.W. Jones Student Union Boardroom pursuant to public notice given October 16, 2019.

Multi-year contracts with annual costs that do not exceed \$100,000. The Board delegates to the President, the provost, or the vice president of finance the ability to execute multi-year contracts with a term not greater than 10 years to the extent that the University's annual costs associated with performance of the contracts will not exceed \$100,000 per year. All multi-year contracts executed by the President, the provost, or the vice president of finance shall be presented to the Board as FYIs. Any multi-year contract that requires the University to incur annual costs that exceed \$100,000 per year must be approved by the Board. Quarterly reports will be provided to the Board as an FYI.
