

Northwest Missouri State University Board of Regents Open Meeting Minutes September 8, 2022 Approved Oct 21, 2022

The Northwest Missouri State University Board of Regents met at 1 p.m. on September 8, 2022, pursuant to public notice given September 2, 2022.
