

## DRAFT Minutes of the Meeting of the Open Meeting of the Board of Regents of Northwest Missouri State University Tuesday, April 28, 2009

The Board of Regents of Northwest Missouri State University met on Tuesday, April 28, 2009, by telephone, at 7:00 p.m., after notice was duly given to each member of the Board.

## **OPEN SESSION**

Roll call was taken with a quorum present at 7:02 p.m.. Vice President of the Board, Don Schneider, called the meeting to order.

After some discussion, it was decided that the agenda item, Discussion and Adoption of Legal Defense Policy and the Amendment of Bylaws, would be taken up in the closed session. The agenda item, Discussion and Contracting for Insurance for University, Regents, Officers and Employees for Items for Which Said Person/Entities are not Covered for Indemnity by the State Legal Expense Fund and/or for Which the Legal Expense Fund Provides No Defense, was also deferred to the closed session.

Resolution #8440: Regent Panethiere made a motion, seconded by Regent Hurst, to retain the firm of Kuhlman, Reddoch & Sullivan, P.C., on an as needed basis, through June 30, 2009 for general legal services. This will allow the board to ascertain its options concerning ongoing legal services.

Regent Panethiere amended his motion to add setting a dollar figure not to exceed \$25,000. A board member or either the outgoing or incoming president may ask for these services. Regent Hurst seconded the amendment.

Regent Panethiere re-amended his motion to state the rate of \$150 per hour and the \$25,000 limit. Regent Hurst seconded the re-amendment.
