



**Northwest Missouri State University Board of Regents
Open Work Session Minutes
Jan. 27, 2017, 9 a.m.**

The Northwest Missouri State University Board of Regents met at 9 a.m. on Jan. 27, 2017 in the Northwest Missouri State University Ballroom of the J.W. Jones Student Union pursuant to public notice given Jan. 25, 2017.
