The Northwest Missouri State University Board of Regents met at 10 a.m. on January 28, 2019 in the J.W. Jones Student Union Boardroom pursuant to public notice given January 22, 2019.

AASCU/Gates Grant Center for Student Excellence – Allison Hoffmann

- We are pleased to be selected as one of six institutions to participate in the development of AASCU's Center for Student Success. The project will focus on using institutional data to identify key performance indicators and validate a set of innovative strategies to support student success initiatives at Northwest. Based on the initial kick-off call, the project will focus on advising and student services, developmental education, pathways, and degree completion among other areas. AASCU's Center for Student Success initiative will enable institutions that are leading student success efforts to work collectively, learn from one another and have access to tools and strategies through AASCU's engagement in a national network supported by the Gates Foundation. Following completion of the project, the initiatives will be scaled and shared with broader AASCU membership. The other institutions participating in AASCU's Center for Student Success include: Austin Peay State University (Clarksville, TN), Bowie State University (Bowie, MD), California State University-San Bernardino (San Bernardino, CA), CUNY Lehman College (Bronx, NY), Henderson State University (Arkadelphia, AR). The 14-month project officially started last week with our kick-off call with AASCU representatives and forming the initial cross-functional campus team. The campus team was put together based on AASCU's request for representation from specific areas within the institution. The initial campus team includes Dr. John Jasinski, Dr. Jamie Hooyman, Dr. Mike Steiner, Dr. Matt Symonds, Egon Heidendal, Julie Johnson, and Allison Hoffmann. As we continue to learn more about the project, additional members may be added to the campus team. Next steps include conversations with key stakeholders across campus and completion of the institutional transformation assessment (ITA) in preparation for AASCU's campus visit #1 in March-early April.
