



**Northwest Missouri State University Board of  
Regents  
Open Meeting Minutes  
September 3, 2020**

The Northwest Missouri State University Board of Regents met at 1 p.m. on September 3, 2020, in the J. W. Jones Student Union Ballroom, pursuant to public notice given August 27, 2020.

The following members of the Board were present: Chair John Moore, Lydia Hurst, Marilou Joyner, Jason Klindt, Roxanna Swaney and Mel Tjeerdsma in the Ballroom; and Debbie Roach via telephone. Also present were University President John Jasinski and Attorney Sean Tassi.

A quorum being present, Regent Moore called the meeting to order at 1 p.m. and roll call was taken.
