Board of Regents
Open Meeting Minutes
February 15, 2022

The Northwest Missouri State University Board of Regents met via telephone at 10:30 a.m. on February 15, 2022 pursuant to public notice given February 14, 2022.

The following members of the Board were present: Chair John Moore, Stephen Coppinger, Shanda Durbin, Jason Klindt, Debbie Roach, Roxanna Swaney and Mel Tjeerdsma. Also present were: President John Jasinski, Vice President of Finance and Administration Stacy Carrick, Assistant Vice President of Finance Mary Collins and General Counsel Hayley Hanson.

A quorum being present, Regent Moore called the meeting to order at 10:30 a.m. and roll call was taken.

To grant authorization to the appropriate officers of the University to request a rating for the Series 2022 Bonds from one or more nationally recognized securities rating agencies, take necessary actions to carry out the offering for sale of the Series 2022 Bonds and to grant authorization to the Final Terms Committee to approve the final terms of the Series 2022 Bonds, within the following parameters:

Principal amount not to exceed \$35MM	\$33.6 Million	\$33.0 Million
True Interest Cost (TIC) not to exceed 2.75%	1.75%	2.25%
Final maturity not later than 6/1/2029	6/1/2029	6/1/2029
Weighted average maturing no less than 2 years, and no more than 6 years	3.8	3.9
Present value savings shall be not less than 3.00%	6.89%	5.09%
