



**Northwest Missouri State University**  
**Board of Regents**  
**Open Special Meeting Minutes**  
**July 22, 2022**  
**Approved August 4, 2022**

The Northwest Missouri State University Board of Regents met via Zoom at 9 a.m. on July 22, 2022, pursuant to public notice given July 20, 2022.

The following members of the Board were present: Chair John Moore, Steve Coppinger, Shanda Durbin, Jason Klindt, Debbie Roach, Roxanna Swaney and Mel Tjeerdsma. Also present were: Interim President Dr. Clarence Green, Vice President of Student Affairs Dr. Matt Baker, Vice President of Finance Stacy Carrick, Provost Dr. Jamie Hooyman, Interim Vice President Dr. Egon Heidendal, Vice President of University Advancement Mitzi Marchant, Athletics Director Andy Peterson, Assistant Vice President Krista Barcus, Assistant Vice President Mary Collins, Assistant Vice President Dan Haslag, Assistant Vice President Brandon Stanley, Director of Capital Programs Scott Kuhlemeyer and General Counsel Hayley Hanson.

A quorum being present, Regent Moore called the meeting to order at 9:01 a.m. and roll call was taken.

Regent Roach left the meeting due to connectivity issues.
