

Northwest Missouri State University Board of Regents People, Finance and Operations Committee Open Meeting Minutes October 21, 2025 Approved on December 9, 2025

The Northwest Missouri State University Board of Regents People, Finance and Operations Committee met in open session via Zoom on October 21, 2025, pursuant to public notice given on October 16, 2025.

The following members of the People, Finance, and Operations Committee were present: Chair Steve Black, Shanda Durbin and Mel Tjeerdsma. Roll call was taken at 10:01 a.m., and a guorum was established.

Board resolution authorizing Northwest to apply to the Missouri Department of Natural Resources Recreational Trails Program for the purpose of securing grant funding for the Rails to Trails program

President Tatum presented the following FYIs to the committee:

• Academic Affairs

- o The annual First Gen Celebration will be on November 11, from 2:00 to 3:30 in the BD Owens Library.
- o Fall Commencement will be on December 12 at 10 am and 2 pm. Regents are welcome to participate.
- The Celebration of Scholars is scheduled for April 1. The hope is to make this event into a larger event.
- The 2026 SOAR dates have been scheduled and are as follows:

Administration

- COPHE is creating a platform to explain its relevance, to share with legislators and others.
- Strategic planning has begun and will live within the President's Office with Jacob Wood guiding the process. A steering committee has been selected and is being reviewed by Northwest leadership.
- The provost search will begin soon. Krista Barcus and Stacy Carrick are co-chairs of the search and are currently developing the profile with search firm Anthem Academics.
- The Wesley property sales agreement has been signed. The environmental report showed some concerns, but they can be resolved.
- Leisha Barry was appointed to the Board and will attend the meeting on October 24.

Athletics

- The 988 Mental Health Hotline was promoted during the September 27 football game.
- The paid parking lot #60 sold out for the September 27 gameday.
- Bearcat Basketball season tickets are on sale.

Culture

- Vice President Barcus reported that the Workday project continues, with the current focus being on validation/testing.
- An Administrative Specialist, Megan McAdams, joined the Human Resources Office on September 15.
- Lee Allard has submitted his retirement notice. His retirement date is December 19.
- Lieutenant Holmes will be joining the University Police Department on Oct. 1.
- Staff evaluations are due on October 1.
- Health screening forms must be submitted by October 15.

Finance & Administration

Vice President Carrick reported that most of the bottom line in the budget has already been committed.

- Some budget line carryforwards will not be able to be moved forward this fiscal year, as has been the
 practice in past years. Vice President Carrick will meet with each NLT member who has funds in those
 areas.
- The FY25 budget ended in the positive.
- Vacant positions will be reviewed within each division to determine if hiring some positions can be delayed or not filled to recover some wage savings.
- It is important to decrease spending for FY26 and FY27.
- Vice President Carrick reported that 28% of Workday has been implemented on the platform side.
- o Domestic water lines will be addressed this October instead of the previously scheduled spring of 2026.

Student Affairs

- A group from Student Affairs will support an employee well-being initiative that will take approximately
 10 minutes a week to support.
- Northwest Foundation board member Jenny Burkehead is hosting a comedy show event in Gladstone, MO, on October 9, with proceeds to be given to campus mental health initiatives. The comedian is a Northwest alumna.
- o Funds are available nationwide if someone wants to start a Turning Point USA chapter in our area.
- o Greek Life numbers are on the upturn, with 20-30 additional students living in Roberta Hall.
- Student Senate is partnering with Athletics on improving the football gameday experience and providing shakers to the students attending the games.

University Advancement

- Campaign Counsel JGA will be having an initial meeting with the committee this week.
- o The fall Northwest Foundation Board meeting will be Oct. 22 and 23 on Northwest's campus.
- The Class of 1975 50th Year Reunion is taking reservations and has 40 registered for the reunion at this time.
- The Powering Dreams event scheduled on November 7 has been transformed from a reception to a luncheon. An RSVP is being collected for attendance.

It was moved by Regent Tjeerdsma and seconded by Regent Durbin to adjourn the open session and move to closed session pursuant to R.S. MO 610.021(2) regarding the lease, purchase or sale of real estate.
