

## Northwest Missouri State University Board of Regents Open Meeting Minutes October 24, 2025 Approved on December 11, 2025

The Northwest Missouri State University Board of Regents convened at 10:00 a.m. on Octoober 24, 2025, in Harr Athletic Succuess Center in Lamkin Activity Center on the Northwest Missouri State University campus following public notice issued on October 16, 2025.
