 - Brenda will send Janice a list of people who donate to the scholarship so she can write thank you notes to them.
 - There was discussion about how to make sure new retirees or people who are approaching retirement know about NWRA. In the past, the Provost's Office has sent

Christine a list of faculty who have announced their intention to retire, and Christine has sent them an email inviting them to join. Several years ago, Human Resources told Christine they were not allowed to send her a list of staff who were planning to retire, but they could put the letter in their retirement packet. When Christine asked if an NWRA representative could do a 5-10 minute presentation at the Preretirement Meetings provided to NW faculty and staff, she was told that the schedule was full but they would share a letter. These are all important contacts Christine had initiated and last year asked to be taken over by a Board Member-at-Large, offering to share her written instructions and mentor the lead person. We need to have a Board meeting so we can get this set up.

- Results of other discussion:
 - Ray will work with Brenda and the Foundation (not Mark Hornickel because we are not a university organization) to update the brochure (the fun things we do and the money we raise for students), get it printed and placed in appropriate places, including the retirement packets. Jody Strauch and the Foundation may have students who can help with the layout, pictures, etc.
 - 2. Janice will talk with Jody Strauch to see if she can get a feature article promoting NWRA—who we are and how we give back.
 - 3. Brenda will ask again about someone speaking at the Pre-retirement Meetings.
 - 4. Brenda will ask HR if she is allowed to send Christine the contact information for people who either retired or are about to retire each month.

 John will give an update around December, once he knows the changes in MO and US.
- d. Art auction for scholarship (Janice Falcone)

 Janice and Rosalie are still exploring possibilities for an art auction.
