Volunteers for a planning committee were Janice Falcone, Barb Nelsen, Rosalie Weathermon and Ray Courter. Many ideas were suggested and discussed--ways to gather art, possible other ideas of buying a Musician/artist for an event to come and play or perform, a silent auction, display items at the Alumni house, send out a press release to invite other alumni etc. to donate items or artifacts. Ways to reach a wider audience were discussed by the group along with ways to find items that may have personal connections to a member of the University. Brenda Untiedt suggested selling raffle tickets at football tailgates for choices of specific items. Silent auctions were also discussed with a minimum bid for each item, or people could bid for the first choice of the list of items. We need to coordinate with the art department so we don't compete with their spring and fall sales. We should look for ways to incorporate interest from a variety of community resources.
