

COUNCIL ON TEACHER EDUCATION

Thursday; November 3, 2011

The meeting was called to order by Christine Benson, Chairperson, with the following members present: Karen Becker, Carole Edmonds (left during Director of Teacher Education report), Jason Eggers, Greg Haddock (left during Director of Teacher Education report), Nissa Ingraham, Karen Detrixhe for Joe Kreizinger (arrived during Agenda Item 8), Daniel Larson, Cheryl Malm, Barbara Martin, Mike McBride, Barbara Crossland for Pradnya Patet, Joyce Piveral, Michael Steiner, and Nancy Zeliff (arrived during Agenda Items 4 & 5). The following members were absent: Nancy Foley, College of Education and Human Services; Leslie Galbreath, Ex Officio for Owens Library; and Brian Lanier, College of Arts and Sciences. Public school representatives Brianne Hunter and Diane Moore were unable to attend. Dave Oehler, Michael Hobbs and Tom Smith were also present.

P-12 School Representatives Reports/Updates: Jason Eggers provided a copy of the new Missouri Model Teacher and Leader Standards. It is important for the public schools and universities to collaborate on this. Roger Kurtz with MASA has published the "Ten Facts You Will Not Hear at the Missouri Capitol." They include some positive facts about education in Missouri.

Dr. Steiner moved to approve the minutes of the September 15, 2011, meeting. The motion was seconded by Dr. Martin and unanimously approved.

Dr. Steiner moved, seconded by Dr. Edmonds to approve the agenda. The motion was unanimously approved.

Dr. Steiner moved to consider Proposals 111-10-01 and 110-10-02 as a package. The motion was seconded by Dr. Ingraham and unanimously approved. Dr. Steiner moved, seconded by Dr. Ingraham, to approve Proposal 111-10-01, Change in Degree, M.S.Ed. in English (Option 1) to M.A. in English with English Pedagogy Emphasis, and Proposal 111-10-02, Delete Program Option, M.S.Ed. in English (Option 1). Dr. Smith explained that they made these change since the population for this program is primarily teachers that need an M.A. in order to teach dual credit courses. The motion was unanimously approved.

Dr. Steiner moved to consider Proposals 111-10-04 and 111-10-05 as a package. The motion was seconded by Dr. Edmonds and unanimously approved. Dr. Steiner moved to approve Proposal 111-10-04, Change in Major, Comprehensive Major in English Education, and Proposal 111-10-05, Change in Major, English Education. The motion was seconded by Dr. Crossland and unanimously approved. [An electronic action was taken on Proposal 111-10-05 as an addendum. This action is reported at the end of the minutes.]

Dr. Zeliff moved, seconded by Dr. Crossland, to approve Proposal 111-44-09, Approval of New Undergraduate Certificate Program, Career and Technical Education. This proposal has been previously approved by the Council on December 4, 2009, but it did not complete the full University approval process. The only change in this proposal from the previous proposal was the change of 62-371, Introduction to Special Education, from a two-hour course to a three-hour course. The Council was provided with a copy of the proposal that did not show this change in credit hours. Dr. Zeliff and Dr. Crossland agreed to this change in their motion. The edited motion was unanimously approved.

Dr. Ingraham moved, seconded by Dr. Martin, to approve Proposal 111-14-06, Approval of New Course, Internship in Languages (14-470) and Change in Major, Spanish Education. The proposal was clarified to state that this new course requires the permission of the instructor in addition to the course prerequisites. Dr. Ingraham and Dr. Martin agreed to this change in their motion. The edited motion was unanimously approved.

Dr. Steiner moved to approve Proposal 111-62-02, Change in Course Number and Title, Introduction to Teaching Students with Autism Spectrum Disorders (62-620), change to Introduction to

Autism Spectrum Disorders (62-520). The motion was seconded by Dr. Ingraham and unanimously approved.

Dr. Edmonds moved to approve Proposal 111-62-03, Approval of New Course, Teaching Students with Autism Spectrum Disorders (62-521). The motion was seconded by Dr. Pivaler and unanimously approved.

Dr. Pivaler moved to approve 111-19-02, Change in Course Title, Middle School/Junior Music Methods (19-592), change to General Music Methods. The motion was seconded by Dr. Ingraham and unanimously approved.

Director of Teacher Education Report: Dr. Pivaler shared that the National Council for Teacher Quality has requested documents from us. We will provide them with the information that is public record.

Dr. Malm reported that the redesign efforts in the state entail a large number of changes. We will need to update our matrices to the MoSPE standards. Every standard is on a continuum. The biggest impact is on our advanced programs. We need to show that we are advancing them further on the continuum.

Mike McBride provided information about the transition to Tk20. Students and faculty have been notified about the implementation. The system has many benefits for both the faculty and students. He has attended some classes to answer questions and would be happy to visit other classes, as would Dr. Pivaler or Dr. Malm. Students have expressed that they would like to preview the Tk20 system prior to purchasing their subscription, and we will be showing a preview of the basic system during the week after Thanksgiving. Students that will be student teaching and graduating in the Spring will not be required to use Tk20. If they choose to purchase it, the cost will only be \$65. They would then be able to use it on the job.

Mike McBride shared information on dispositions of the advanced programs. This will be shared with the faculty, and they would like feedback. This system would be completed for admission to the program, by the advisor and two faculty after the student has completed 13 hours, and by the student as a self assessment at the completion of their program.

Dr. Zeliff moved, seconded by Dr. Pivaler, to adjourn. The motion was unanimously approved.
