

# COUNCIL ON TEACHER EDUCATION

Thursday, October 11, 2018

3:30 p.m.

The meeting was called to order by Everett Singleton, Chairperson, with the following members present: Ashley Black, Greg Haddock, Joseph Haughey, T.J. Johnson, Jeongae Kang, Jodie Leiss, Andrea Mason, Mike McBride, Greg Rich, Linda Smith, Rena' Smith (arrived during Agenda Item 6), Jamie Thieman, Jennifer Wall, Tim Wall, and Amy Wilson. The following members were absent: Haley Klein, Graduate Student Representative; Jackie Lacey, Agriculture/Business Education; and Neil Nuttall, Ex Officio for Northwest-Kansas City. Public school representative Shannon Nolte was unable to attend. Cari Cline was also present.

## P-12 School Representatives Reports/Updates

Jamie Thieman reported on the activities that are occurring at Maryville Middle School.

Dr. Haughey moved to approve the minutes of the September 6, 2018, meeting. The motion was seconded by Dr. Rich and unanimously approved.

Dr. Rich moved, seconded by Dr. Leiss, to approve the agenda. The motion was unanimously approved.

Dr. Linda Smith moved, seconded by Ms. Mason, to approve Proposal 118-17-11, Change in Major, Mathematics Education Comprehensive. The purpose of the change was to add 44-141 Computer Programming as an option in the major. Dr. Jenni Wall requested that 17-316 Linear Statistical Models be added as an elective to the major. Dr. Linda Smith and Ms. Mason accepted this change as a friendly amendment to their motion. The motion was unanimously approved pending the change in the proposal.

Dr. Linda Smith moved to approve Proposal 118-17-11, Change in Minor, Mathematics. The motion was seconded by Dr. Haughey and unanimously approved.

Dr. Jenni Wall moved, seconded by Ms. Mason, to approve Proposal 118-61-01, Change in Course, 61-616 Teaching Strategies, change from 5 to 2 credit hours. This course fulfilled the matrix requirements with 2 hours of credit with other course additions that increased the total hours for both alternative certification and post-baccalaureate programs of study. The motion was approved with one abstention.

Dr. Rena' Smith moved to bundle Proposals 118-44-01, 118-44-02, and 118-44-03. The motion was seconded by Dr. Haughey and unanimously approved. Dr. Rich moved, seconded by Dr. Rena' Smith to approve the following proposals:

- Proposal 118-44-01, Change in Course Number, 44-510 Coordination of Cooperative Education, change to 44-410
- Proposal 118-44-02, Change in Course Number and Hours, 44-580 Methods of Teaching Business and Marketing, change to 44-480, 3 credit hours
- Proposal 118-44-03, Change in Course Number, 44-584 Implementing Business and Marketing Education Programs, change to 44-470

Ms. Cline explained that this will not impact the consortium participants taking these courses. This provides more flexibility in the instruction of the courses, and these courses are not included in any graduate programs. The motion was unanimously approved.

## Director of Teacher Education Report

Dr. Tim Wall reported that approximately 60 faculty came together at the PEU retreat on September 28 to attend breakout sessions on the topics of Accreditation, Advisement, Matrices/Certification, and MEES/MOFTA. Faculty (Drs. Haughey, Singleton, Dimmitt, Baugher and Kiene) who attended the CAEP and AAQEP conferences this past month shared their experiences and focused our groups on national accreditation. They will be developing teams based on the national accreditation options to meet AAQEP and CAEP standards. Dr. McBride provided an update on the changes to the MoCA assessments and to the MoGEA, including revision of the MOCA for social studies (from 6 sub-tests to 1). We are looking for ways to assist our teacher candidates to build their knowledge and skills as we transition from seniors developing the MoFTA during student teaching to completing the newly-required MEES (Missouri's Educator Evaluation System) during student teaching. The MEES is a statewide, rubric-based assessment of clinical practice and teaching effectiveness. It is used by many districts and principals to evaluate teacher performance, and aligning to this for teacher candidates makes sense, as they will also be evaluated on the same standards by their principals. Dr. McBride will be coordinating/developing a suite of MEES resources and posting them to Northwest education student teaching website to assist candidates and faculty members in preparation for this new certification examination and requirement. Dr. Wall spoke to the Northwest Foundation earlier today about the quality and growth of our education programs, and there was interest in supporting our work in the short and long term.
