

# COUNCIL ON TEACHER EDUCATION

Thursday, December 5, 2013

3:30 p.m.

The meeting was called to order by Jill Baker, Chairperson, with the following members present: Blaine Adams, Christine Benson, Rod Barr (arrived during Agenda Item 4), Heidi Beatty (arrived during Agenda Item 4), Max Fridell, Dan Gordon, Greg Haddock, Joe Kreizinger, Cheryl Malm for Joyce Pival, Rena Smith, Shirley Steffens, Linda Sterling, Jennifer Wall, and Katie Whelan. The following members were absent: Leslie Galbreath, Ex Officio for Owens Library; Mike McBride, Ex Officio for TESS; and Nancy Zeliff, Ex Officio for Career Education. Public school representatives Jason Eggers and Lori Snead were unable to attend. Jawad Sadek and Dave Oehler were also present.

Dr. Fridell moved to approve the minutes of the November 14, 2013, meeting. The motion was seconded by Dr. Benson and unanimously approved.

Dr. Benson moved, seconded by Dr. Kreizinger, to approve the agenda. The motion was unanimously approved.

Dr. Fridell moved to remove Proposal 113-17-02, Change in Degree, M.S.Ed. in Teaching: Mathematics, from the table. The motion was seconded by Dr. Benson and unanimously approved. The floor was opened for further discussion. The Professional Education Department would like to collaborate more with the Department of Mathematics, Computer Science, and Information Systems and have further discussion about the design of this program. This program was designed based on input from an advisory committee. The cohort of students interested in this program is planning to begin the program this summer. Dr. Gordon moved to table this proposal until the COTE meeting scheduled for January 16, 2014. The motion was seconded by Dr. Fridell. The motion carried with seven supporting, two opposing, and three abstaining.

Dr. Benson moved to approve Proposal 113-19-05, Approval of New Courses for Masters in Music Education. The motion was seconded by Dr. Malm and unanimously approved.

Dr. Benson received feedback that a representative from fine and performing arts education needs to be added to the Assessment System Evaluation Team (ASET). Dr. Benson moved to add a fine and performing arts representative to ASET. The motion was seconded by Mr. Barr and unanimously approved.

## Director of Teacher Education Report

Dr. Malm reported that Dr. Pival is attending the Missouri Council of Education Deans in Columbia. We have received data back from the recent administration of the MoGEA to thirty Northwest students, and she provided some of this data. The provost and presidents of Missouri have received a concession from the Commissioner that institutions will be allowed to use their cut scores on the MoGEA for two years rather one year.

The comment period for the new compendium is now open. As many comments as possible need to be submitted.
