P-12 School Representatives Reports/Updates

Shannon Nolte reported that the superintendents met earlier today, and they are interested in the change of leadership at DESE. There will be new testing implemented in the spring.

Dr. Linda Smith moved to approve the minutes of the November 9, 2017, meeting. The motion was seconded by Dr. Rena Smith and unanimously approved.

Dr. Gordon moved, seconded by Dr. Linda Smith, to approve the agenda. The motion was unanimously approved.

Dr. Haughey moved, seconded by Dr. Kreizinger, to approve Proposal 117-17-20, Change in Major, Comprehensive Mathematics Education. Dr. Malm explained that the technology course was removed to align with DESE certification requirements. This allows students more flexibility in their program. The motion was unanimously approved.

Dr. Farnan moved, seconded by Dr. Rena Smith, to approve Proposal 117-62-01, Change in Program, M.S.Ed. in Reading. Dr. Linda Smith explained that the program has been redesigned to be delivered online. This program is closely aligned to the reading matrix with a few additional courses required for certification. The motion was unanimously approved.

Dr. Wall moved to bundle Agenda Items 6-11. The motion was seconded by Dr. Gordon and unanimously approved. Dr. Haughey moved, seconded by Dr. Rena Smith, to approve the following:

The motion was unanimously approved.

Director of Teacher Education Report

Dr. McBride reported that the APR results have been provided for our completers from last year. Starting next year DESE will begin taking actions as a result of the report. Last year, these programs were placed in tiers. The programs are now being identified as Accredited, Provisionally Accredited, and Unaccredited. This year, every program in the state is going to be accredited until they compile two years of data. The data results we received showed that all of our programs achieved the points necessary to be accredited. The MEES is currently one-fifth of our APR. The MEP is likely to be eliminated. The data we are collecting this year will be used for APR 2.0. They will only be looking at completers that were certified.

Dr. Wall reported that the redesigned education program is providing a much richer experience for our students. We recently received a federal land/water conservation fund/Missouri Department of Natural Resources grant to build an outdoor classroom. Student fees support renovating classrooms, and one of the classrooms in Brown Hall is being renovated as a transformation of learning which provides a classroom space that supports electronic and face-to-face collaboration and student-professor interactions. There are 175 new online students in the graduate education programs.
