Public school representative Brianne Hunter was unable to attend.

Dr. Foley moved, seconded by Dr. Ingraham, to approve the agenda. The motion was unanimously approved.

P-12 School Representatives Reports/Updates: Mr. Eggers reported that they are continuing to work with intervention strategies at the high school. They want to utilize our students as effectively as possible in their schools. Ms. Moore reported that Maryville Middle School is implementing AIMSweb, a benchmark and progress monitoring assessment system. MSIP 5 contains a number of changes, and there will be a comment period in the near future. One of the challenges is that students will be tested in biology and two other science areas along with an end of high school science test. In northwest Missouri, many schools have received Distinction in Performance, and there has been some concern expressed about this.

The floor was opened for nominations for the office of Chairperson. Dr. Steiner nominated Dr. Christine Benson. The nomination was seconded by Dr. Ingraham. Carole Edmonds moved to cease nominations. The motion to cease nominations was seconded by Dr. Martin and unanimously approved. Dr. Ingraham moved, seconded by Dr. Foley, to accept Dr. Benson's nomination by acclamation. The motion was unanimously approved.

The floor was opened for nominations for the office of Vice Chairperson. Dr. Steiner nominated Dr. Nissa Ingraham. The nomination was seconded by Dr. Edmonds. Dr. Benson moved, seconded by Dr. Foley, to cease nominations. The motion to cease nominations was unanimously approved. Dr. Steiner moved to accept Dr. Ingraham's nomination by acclamation. The motion was seconded by Dr. Edmonds and unanimously approved.

<u>CBHE Program Review Process:</u> We have completed our program review and typically the review is for programs for low enrollment. CBHE will monitor these programs for growth. <u>Maryville Middle School & Northwest Partnership</u>: The minutes from the partnership meeting on May 10 were shared. The goal of this partnership is to collaborate and maintain a good working relationship.

Director of Teacher Education Report

Dr. Piveral reported that we had attended the NCATE convention and training on the next accreditation cycle. We need to partner with our area schools in an intentional way. We have purchased the Tk20 assessment system and are implementing it. This is a robust system. Mike McBride will be leading us through this process and analyzing the data. There needs to be a year's worth of data in the system for our report. Dr. Malm explained that the timeline on the report has changed since we need to submit a preliminary report six months prior to the campus review.
