Organizational Structure Support & Strategic Operations Reports

Leadership Advisory Team – Clarence Green and Krista Barcus

- The resolution to compensate staff for additional duties did not move out of committee for a vote. The NLT will continue working to resolve the issues which prevented forwarding of the resolution.
- Covid mitigation measures have been modified, since there are no current cases in Nodaway County.
- Some items have been removed from the Covid dashboard; expect weekly updates between now and August 1st. The mandate for face coverings continues until June 7th.
- Krista displayed and explained the lactation policy, which is being drafted in accordance with the federal guidelines currently followed by the university. All employees applying for maternity leave will receive a copy of the policy and instructions for access to the lactation room. Only one room is currently designated for the purpose, but backup rooms are available.
- The shift differential policy under discussion will apply to second and third shift employees once the budget has been approved, which is expected to happen in June.
